How to become a Pennsylvania Named Plaintiff:

A fee is required to become a Named Plaintiff. The total fee is \$400. We have payment plans and they are very flexible. If the entire amount cannot be paid at once, we would prefer to receive at least half of the total fee as a down payment. **Once one-half of the total fees have been paid, you will be considered a client of this law firm and will be listed as a Named Plaintiff in the litigation against the Pennsylvania Parole Board.** No one will be listed as a Named Plaintiff until one-half of the total fees have been paid. Rest assured, any reasonable arrangement for paying the balance of the fee will be approved. For hardship cases such as fixed incomes, special arrangements can be made. In general, if you are working with us, we will work with you and your family. We prefer to receive our legal fees from families for the simple reason that prison cashiers often refuse a request to issue us a payment. Personal checks are accepted as well as money orders. We encourage all family members to routinely log onto our website. All future court filings will be posted on the website, as well as monthly progress reports.

To communicate information about the law suit, we have utilized client representative at the various institutions. Monthly reports have been sent out to our representatives advising of our progress. This system works very well and enables us to keep everyone informed. We would like to have 20 client representatives at each institution. To qualify as a Client Representative, he/she must be a Named Plaintiff and capable of understanding legal issues so they can explain this to other clients. Client Representatives must also be willing to assist less literate clients with our 13 page Client Questionnaire, and disseminate our information to interested non-clients so others can decide

If they would like to join. We do not expect Clients Representatives to sell or promote this litigation. Our best salesperson by far is the Pennsylvania Parole Board. We get many clients just after receiving a set-off.

Again, thank you for expressing interest in our lawsuit. There is tremendous strength in numbers. Just the feat of organizing inmates around a single issue terrifies the bureaucracy. We are looking forward to representing you in the event you decide to join our litigation.
